#### Biography:

Tom Flint was born in 1956 in Indianapolis, Indiana. After completing his early education he studied for the priesthood in the Roman Catholic Church from 1976 to 1981. In 1981, Flint graduated from St. Pius X College Seminary in Covington, Kentucky with a BA in Philosophy. He then pursued graduate studies in philosophy and theology at St. Mary's College in Emmitsburg, Maryland.

Between 1982 and 1986, Flint served in the United States Air Force at Ramstein Air Force Base in Germany and at McChord Air Force Base in Tacoma, Washington. In 1986, Flint was discharged following the discovery of his homosexuality.

Radicalized by his 1987 attendance of the National March on Washington for Lesbian and Gay Rights, Flint became a militant Gay activist in Seattle, Washington. He co-founded ACT-UP/ Seattle in 1988 and was active in Queer Nation and a number of other militant activist organizations. Between 1987 and 1999, Flint also worked as writer and/or editor for the Seattle Gay News. During his time at SGN, he bore witness to the activist struggles of the crisis years of the AIDS epidemic, while chronicling the growth of a conservative, fundamentalist backlash against the gains made by the Gay Rights movement during the 1970s and 1980s.

Following Flint's departure from the <u>Seattle Gay News</u> in 1999, he traveled throughout Southeast Asia. A Buddhist since 1993, Flint deepened his faith by becoming a Buddhist monk while in Cambodia. Flint's purpose for the trip was twofold: to collect information about the AIDS epidemic in Southeast Asia, while promoting AIDS education and prevention through public speaking; and to study and practice traditional Buddhist psychology and meditation with experienced teachers in order to better understand the theory and practice of nonviolence and how this may benefit the work of social justice activism in the United States

During his time in Southeast Asia, Flint also conducted an intensive study of social change models and became committed to the theory and practice of nonviolent social change as taught by the Buddha, the Dalai Lama, Mahatma Gandhi, and Martin Luther King Jr. After this study, Flint became active in the *Engaged Buddhism* movement, which strives to promote the theory and practice of nonviolence and Buddhist Dharma as a method of social change.

#### **Scope and Contents:**

The Flint Papers consist of two Record Series: Subject Files, which also include two groups of organizational files and one group of files on anti-gay campaigns in Washington State in the 1990s, and Photographs. However, individual and smaller groups of photographs are scattered throughout the Subject Files. Flint's original order and folder titles have been retained.

Generally speaking, the Subject Files cover four main areas: 1. The Subject Files Flint collected as background information for the articles he published in the <u>Seattle Gay News</u> and other Gay publications between 1987 and 1999; 2. The organizational files of Act-Up/Seattle that Flint inherited when the organization dissolved in 1993; 3. The organizational files of the 1993 March on Washington Northwest Regional Organizing Committee; 4. Opposition research on anti-gay, "religious-right" organizations that launched statewide anti-Gay political campaigns in Washington state in the 1990s. The Subject Files constitute the bulk of the Tom Flint Papers.

The Subject Files reflect Flint's interests as a journalist. Newspaper and magazine articles and press releases constitute the vast bulk of the collection. The topics focus on the social, political, religious, and economic aspects of the AIDS epidemic and/or being gay in America during the 1990s and relate both pro-gay and anti-gay points of view. The materials also reflect events around the United States, but with a decided slant toward the Pacific Northwest and Washington, DC. Although the bulk of the papers were created between 1987 and 1999, many items in the collection reflect prior events. While Flint undoubtedly used the organizational files to inform his work as a journalist, they also reflect his direct involvement in the struggle for gay-rights and against the AIDS epidemic. Occasional correspondence and emails are scattered throughout the collection. Flint's unpublished history/autobiography provides the researcher with a personal view of how Flint was affected by his experiences.

The Photographic Series contains 2,382 colored images and negatives of Gay, Lesbian, Bisexual, and Transgendered (GLBT) activities and individuals, 1988-1993, by Seattle photographer, Donald Auguston. The images depict the wide diversity of individuals who make up the GLBT community. A few individuals are identified, but most are not.

The many victim obituaries (celebrity and unknown) reflect the spread of the HIV/AIDS epidemic through American society during this time.

- 11-19: AIDS Coalition to Unleash Power (Act-Up): Newspaper and magazine articles, brochures, photos, and flyers offering a general overview of various Act-Up protests around the country during the 1990s. Although the material covers the entire country, the Pacific Northwest is also covered in some depth. Act-Up became a controversial nationwide organization, with chapters in various American cities, that protested against national, state, and local policies addressing the AIDS epidemic that Act-Up believed were discriminatory against gays or that did not meet the problem adequately enough.

She was later reinstated by a federal judge.

State politics and media coverage contributed to the notoriety and controversy surrounding the Farmer case, which became a cause-celebre to many in the local and national gay communities.

Essentially, these gay conservatives believed that the safe sex message had failed and they sought a "new regime of 'responsible' behavior on the part of gay men, and argued for monogamy, gay marriage, and heightened governmental regulation of sex to achieve it." One group countering the "Gay Right" was "Sex Panic." "Sex Panic," made up primarily of activists and academics (Examples: Alan Berube, Eric Roffes, Richard Berkowitz), defended a belief in sexual freedom, or the right to have sex however, wherever, and with whomever they pleased. The "Gay Right" saw this promiscuous point of view as a lethal and destructive form of narcissistic hedonism.
- **19-20: Genetics of Homosexuality**: Newspaper and magazine articles covering the debate over the biology of homosexuality. The articles reflect the differing opinions about this controversial subject.
- **21-22: Gorton, Slade (U.S. Senator, Republican, Washington**): Newspaper and magazine articles and press releases documenting Gorton's conservative, political points of view.

The role of homosexuality in the mass suicide was a controversial subject inside and outside the gay community.

Consequently, gays and lesbians, many of whom were Democratic backers of Clinton, were disappointed in Clinton's leadership on this issue.

In contrast to the grass roots organization of the three previous marches in 1979, '87, and '93, the 2000 march would be organized primarily by the HRC, the largest gay rights organization in the U.S. Some gay activists were opposed to this "corporate" approach to the March On Washington. A heated debate within the gay and lesbian community ensued, but the HRC eventually overcame these disputes and continued to organize the Millennium March on Washington.

Moorehead, who played a major role in building Overlake into a powerful and well-financed church, lost his position of influence during the late 1990s following an arrest for public masturbation in Daytona Beach, Florida. Allegations by parishioners, suggesting a larger pattern of sexual misconduct, also played a role in Moorehead's down fall.
